The first use of this power can be traced back to 1775 when the Continental Congress authorized President Hancock to use force in stomping down Shay's Rebellion, an insurrection movement in Massachusetts where farmers committed violent acts on U.S. courthouses and other government properties as a form of protest against burdensome economic policies. (The rebellion is named after Daniel Shays, a farmer and soldier who fought at Bunker Hill and was a leader of this rebellion.)
